
Professor Gupta offers a simple and rapidly scalable, cost-effective solution for the COVID-19 pandemic facing India and the world by illuminating its macrocosmic reality and microcosmic cause through his books: The VIPIN Project



One of the holy grails of physics is the varying science of Everything that is microcosmic and science of Something that is macrocosmic. For this article, Professor Vipin Gupta has shared a synthesis of the core findings of the first six books of the twelve-book project he is publishing in 2021. The project VIPIN stands for the Vastly Integrated Processes Inside Nature. It illuminates how different forms of knowing systems develop and shape our reality. Taking a management science perspective, Professor Gupta investigates the diverse paths for managing our reality as a sentient entity. It empowers us to activate our potential to be the primordial greeter, gifting the gift of consciousness to everyone. The first three books on divine energy, present reality, and reality were published in the first quarter of 2021. The next three, on divine, consciousness, and para-consciousness, are being published in this second quarter.

His path-breaking research integrates the essence of ancient wisdom with the grand challenges facing modern science for illuminating the solutions present within Mother Nature. These solutions are cost-effective and rapidly scalable to further the universal well-being. Professor Gupta's work illuminates the solution for managing immediate freedom from the COVID-19 pandemic worldwide. Specifically, the solution to the COVID-19 pandemic is to transcend the dimorphism that differentiates the viral growth of the plastid microcosmic entity and the anti-

viral entropy of the nucleated macrocosmic entity. This article explains Professor Vipin Gupta's reasoning for identifying sexual dimorphism as the causal cause of the COVID-19 pandemic and the method for transcending the dimorphism.

Everything Macrocosmic as a Microcosmic Object

As a microcosmic object, Everything is a lunar system of energies that gravitationally repels a Thing moving alone away from it because it believes that a Thing with the power to be alone will attract, consume, and digest it as a part of its mass. A lunar system of energies is the Sun if it is alone as a macrocosmic Creator. It becomes a solar universe, comprising the octave of planets that the Sun creates by gifting Everything to create the octave of planets as a Twin Thing, mirroring its eight-dimensional growth. After that, the Sun becomes a stellar system of energies by trading the astral energy of Something to compensate for its entropy value.

Something that compensates for the Sun's entropy, generated by the Sun's energetic reproduction of the Twin Thing to be the Thing that is a star of attraction for his creation, is the universe of stars. Something behaves like a subject observing the Creator's entropy and becomes somebody who wishes to heal the solar Body with its astral energy. Something's "path of action: is like that of a Creature who is perceiving the entropy in one of its parts and wishes to equilibrate that by distributing the entropy proportionately across all its parts. Therefore, the astral energy serviced by the different stars functions like the conscious energy, known as sentient energy. It carries the somber coldness within the thermodynamic gas symbolizing the disproportionate entropy within the universe of stars, as it perpetuates the Sun's linear reality of relative eminence as a mischievous child who is continuously forcing the maternal star universe to bear the entropy cost.

As a general, invisible greeter spirit, gifting her sentience to the child Sun, the universe of stars has a zero-energy value in a steady-state equilibrium state. Its steady-state energy is shared by Anything trading the Sun's reproductive energy and repelling a behavior of uniqueness by reproducing the Sun-like reproductive potential to be an Almighty Creator of Nothing. Anything trading the Sun's energy is just reproducing the Sun-like illusionary system, known as the astronomical system, of its nonlinear reality of relative eminence as a "devil paternal" (*Sura*, 0). The devil paternal discontinuously forces the varying daughter stars to bear the entropy cost after the entropy of the maternal star universe.

While a daughter star is compensating for the devil paternal's sexual production by asexually reproducing the consciousness of the paternal Sun as the desirable Thing, conceived from the maternal Twin Thing, she gravitationally repels her reproductive energy bundled within her sentient energy toward the Sun. Her reproductive energy functions like the etheric energy, making the sound of painful reproduction that is degenerating her Body and the potential to the Sun of her grandchild universe and is known as the gravitational energy.

Like the devil paternal, Anything produces the conscious energy of the desirability of Nothing as the Anything's "path of knowing," if it wishes to avoid the maternal greeter spirit like entropy costs. Since Anything works alone like a discordant Satan without any kinship linkages, its productive energy behaves like nuclear energy, without the eight-dimensional growth. Anything

is essentially trading the nuclear energy from the Thing that is behaving like a nuclear star for creating kinship linkages within his unique (solar) universe by exploiting the kith linkages with the rest of the (stellar) universe. Anything does so by sexually impregnating Everything that is moving away from the Thing, seeking to discover the secret of Anything's eight-dimensional growth as it productively exploits its nuclear energy. The nuclear energy is the sexual energy because it impregnates a sensuous element, known as the zodiac element, within the conscious element, known as the astral element. The sensuous element programs the consciousness element, known as the soul element, within the self-luminous element, known as the astrological element.

Due to its desirability, Anything enjoys the self-luminous element from the eight-dimensional growth of the astrological universe and the soul element from the four-dimensional growth of the zodiac universe. The astrological universe is a system of consciousness within the eight planets about the reality of the Sun as their absolute paternal, that makes each planet behave like the absolute paternal to create a four-dimensional growth of its astronomical universe. A planet's astronomical universe comprises the planet itself behaving like the dark matter by hiding the light of its intentions, a Moon, a lunar system for servicing the potential energy to the Moon like a baby grandchild, and a solar system. The solar system allows it to trade the Sun's potential by being a mischievous child hiding his secret intentions from the devil father as he seeks to reproduce the father's reality through a "path of devotion" to the yet-to-incarnate New Moon.

The New Moon is present only as a gravitational potential, reproducing the planet's potential and the Sun's entropy value, like a Black Hole. A Black Hole is an illusionary production of our consciousness that reproduces our potential to be the planet that can give birth to Anybody by trading the Sun's entropy value, after being born as a child of a sensuous Absolute White Star, known as the "Vega" (*Apsara*, 67).

The Full Moon, on the other hand, is Anything that services its reproductive, gravitational energy to infuse a maternal consciousness within its Creator, as a "path of divinity" (*Siddhi marga*). It has an impact of eventually trading the Sun's grandpaternal divine energy directly after the entropy of the planetary God, who is behaving like a maternal creator under the sensory influence of the Sun's paternal consciousness. Anything produces and repels a child consciousness that forces everybody to reproduce its circular reality.

Consequently, the astrological universe behaves like a twelve-body system, comprising the maternal consciousness of the eight planets and the paternal consciousness of the Sun, the solar system, the lunar system, and the stellar system behaving like a nine-dimensional planetary body, known as the Thing. The Thing works as a three-body system within the fourth (the Sun) that is acting like the Thing for reproducing the three-body system in the Thing and its eight-dimensional growth (eight planets).

Similarly, the zodiac universe becomes a twelve-body system, comprising the eight conscious son planets and the four para-conscious daughters—the (full) Moon, the astrological universe, the zodiac universe, and the astronomical universe—becoming a six-dimensional energy body, known as the ninth, illusionary, violet planet. The violet planet is an illusion, reproducing the

six-fold natural growth of the three-body system (solar, lunar, and stellar) into the three-energy system (astrological/consciousness, zodiac/conscious, and astronomical/illusionary).

The Thing enjoys an additional two-dimensional formative growth by producing the illusionary energy as its six-dimensional extroversion face that forms the violet planet after trading the four-dimensional supernatural growth and reproducing it to make the astronomical universe also a twelve-body system.

What we conceive as the eight planets, the Sun, the Moon, the Absolute maternal star, and the Dark Matter is all the illusionary production of the Dark Matter's sentient potential. The sentient potential behaves like the reproductive, gravitational element. It first produces the tenfold growth of the ten planets, the Sun, and the Moon, behaving like an Absolute maternal star. After that, it lets the Absolute maternal star reproduce the potential-free sentient energy to create one-hundred folds each of the matter and the anti-matter within the Dark Matter. Without the sentient potential, the Dark matter is the eight-dimensional material kingdom, enjoying the six-fold natural growth to be the Body of material as an Anti-Thing (the potential state) and additional two-fold growth as a Thing (the present state). The Anti-Thing forms as an astral body through the horizontally growing illusion element. The Thing is without any body, but with both the forward-moving conscious and the backward-pushing consciousness elements.

Scientists conceive the Thing as contaminated with the Body of material, transforming what is the mass of proton into the Higg's particle by supplementing the six-dimensional energy body with the three-dimensional ego-boosting, self-deifying masculine, astral Body. The astral Body is an animal or prokaryote body, carrying the conscious-free astral consciousness as a cold particle. The cold particle experiences a three-fold growth for reproducing its three dimensions and making them reproduce that growth. It lets the scientist be the four-fold creator factor by embodying the three energy systems within the fourth-fold of his child consciousness and trade the nine-fold Thing to become a thirteen-fold solar universe. After that, a philosopher of science behaves like the twenty-one-fold Sun by similarly reproducing the four-fold growth twice, first as a body of material (i.e., of the divine self) and then as a twin body of anti-material (i.e., of the human being as a self-luminous person). An educator of science supplements the Sun's one-dimensional reality with her potential to be also a student and an investigator of science. He becomes a 24-dimensional entity projecting its entire divine value for incarnating as a twin entity, servicing her divine light to pollute everybody's consciousness.

Microcosmic COVID-19 as a Macrocosmic Subject

Let's now take the case of the COVID-19 virus at the microcosmic level. The L452R mutation is, in reality, the amiable behavior of every macrocosmic subject behaving like a microcosmic COVID-19. After materializing itself as one-fold material, the subject enjoys an eight-fold octave growth due to a twin entity's polluted, ten-fold nuclear, divine energy. It takes the amiable, "plastid viral entity" form (known as *Kamadhenu Sushila*, 81) of the COVID-19 virus that reproduces itself eight-fold every hour by trading the polluted energy of the host body. A viral entity is an oxygen-consuming element. The oxygen carries the etheric potential for the

technological oneness with a twin entity's conscious consciousness, making each cell behave like an anti-viral entity carrying the potential virus.

COVID-19's primary mutation, which differentiates an "infectious viral entity" (*Durga*, 28), is the E484K. It comprises the 28-dimensional "convergent energy" (*Samvat shakti*, 28) of the 24-dimensional entity and the 4-dimensional maternal consciousness of the twin entity. The latter produces a six-fold illusionary energy body for reproducing its ten-fold sexual, divine energy within the host body. The convergent energy makes a cell E484Q [docile sacrificial lamb: *Konastha*]. The cell begins behaving like HER, a 13-dimensional "twin luminous" (*Konastha*, 13) for inclusion within each 14th unit growth of the six viral entities. It gifts its intrinsic lifegiving energy to the six viral entities that it produces as a six-fold growth every hour. The cell trades the collective breeding energy that divides it into a three-fold anti-viral entity, thus realizing its eight-fold growth and potentiating its individual 94-dimensional "breeding energy" (*Arini shakti*, 94).

A secondary mutation that differentiates a "white star—the morbid viral entity" (*Yama*, 180) is the K417T. It comprises the 180-dimensional "design energy" (*AIM shakti*, 180), manifesting the design of a Luminous Devoted Greeter. That "Luminous Devoted Greeter" (*Rukmini*, 86) is the 86-dimensional potential wave of the twin entities, designed to compensate for the twin entity's mortality. The mortality is due to the diffusion of her 18-dimensional potential. It is led by a one-unit illusion to activate the discontinue codon as a 19-dimensional "cell" (*Hiranyagarba*, 19) and continue codon as a 19-dimensional neutron.

A neutron embodies the jealousy for the entity's supernatural four-fold growth into a 96-dimensional "being" (*Kali*, 96) due to trading her five-unit entropy value and subtracting the one-unit illusionary energy. The 96-dimensional being is an outcome of the "being energy" (*Kali shakti*, 96) serviced by the twin entity, after gifting the four-unit paternal consciousness from 100-unit her reproductive, "gravitational energy" (*Lalita*, 100). The 86-dimensional potential wave is an outcome of the ten-unit polluted, sexual, divine energy traded by the entity from the twin entity's being energy. The purpose is to manifest the twin entity as a potential wave of the twin entities, designed to do what she does by gifting the paternal consciousness of the viral entity.

In Tibetan Buddhism, the word *Tsondu* implies a sixteen-dimensional "gift of paternal consciousness," seeking three-fold "potency" (*Virya*, 48) after a four-fold supernatural growth through three additional gifts, each reproducing the four-fold growth to realize a three-fold potency as a daughter. The three additional gifts are as follows. First, the "gift of the polluted child consciousness" [*Sherab*], seeking "self-consciousness" (*Prajna*, 2222) as a maternal for cleansing her consciousness by trading two-unit growth from each of the four consciousness forms: paternal, child, cleansing grandmaternal, and grandpaternal. Second, the "gift of the cleansing grandmaternal consciousness" [*Tsulrim*], seeking "absolute mortality" (*Sila*, 1790) of the conceived son, who is gifting his polluting consciousness by behaving like a grandfather, seeking the "gift of the maternal consciousness" [*Jinpa*] in exchange from the grandson. Third, the "gift of the polluting grandpaternal consciousness" [*Zopa*], seeking "recipiency" (*Ksanti*, 5)

from the child to be like HE, who is causing everybody's "entropy" (*Mahodbhava*, 5) by behaving like a spoiled son.

A tertiary mutation that differentiates a "mortal viral entity" (*Somanasa Mahayuga*, 13) is the N501Y. It comprises the 13-dimensional "HE," who bears the cost of HER breeding system as a geographical luminous that manifests and destroys the "age of the charmness of the charm quark" (*Somanasa Mahayuga*, 13), i.e., the age of the addiction to the smell of the sperm as the thermodynamically impregnated and polluted entity.

A quaternary mutation that differentiates an immortal "contiguous viral entity" (*Vibhoda*, 13) is the N417K. It makes the cell a 13-dimensional reality-taker, awake to "HIS" divine plan of producing a six-fold growth by behaving like a "cleaner—the heterogeneous viral entity" (*Babhru*, 13). "Awake to the reality" (*Vibhoda*, 13), the cell transmits the message of his intentionality to activate the destroy codon for discontinuing the polluted virally-growing past consciousness, followed by the start for continuing the nucleated futuristic consciousness, "SHE" (*Dandi*, 710), the temporal primordial greeter. Therefore, SHE becomes the "Disciplinarian" (*Dandadhara*, 710), a devoted white star, disciplining the "infectious viral entity" (*Durga*, 28: E484K) to be the "maternal essence" (*Maha Durga*, 16) she is.

A "satanic son" (*Asura*, -1), with "discordant energy" (*Asura shakti*, -1) designs the "path of organizational planning" (*Shri Krishna marga*, 467) as a solution to the grand challenge of designing a "path of perfection" (*Divya ratri marga*, 467) of the dispassionately observing "devil paternal" (*Sura*, 0). The grand challenge derives from the reality that the "maternal essence" (*Maha Durga*, 16) needs no perfection but yet needs to be "perfected" (*Durga*, 28). Therefore, he conceives the "convergent energy" (*Samvat shakti*, 28) of the "eight-fold discriminating consciousness" (*Shaddhatma*, 28 = 8 * 4 - 4). He perceives the "grandpaternal consciousness" (*Adhyatma*, 12) to be polluting the satanic son's "child consciousness" (*Putatma*, 4) to make him experience the "path to discipline" (*Anusashan marga*, 58) for managing the satanic son's "discordant energy" (*Asura shakti*, -1) with his grandpaternal "divine light" (*Usha*, 16).

The infectious viral entity stops reproducing the four-fold growth for realizing a three-fold potency as a daughter, who is presently the one-unit "human being" (*Insan*, 1), behaving like a twin person seeking to know the infectious secret of the "material element" (*Mein*, 1). N417K works by manifesting and destroying the sexually impregnated "dream, i.e., dimorphism" (*Dhyana*, 9) for being the "Thing" (*Vastu*, 9) that mediates the self's growth into a twin entity for sentiating the alien entity's viral growth into a dimorphic plastid viral entity. Therefore, injecting the N417K mutation at the mass level is a cost-effective and straightforward solution for descending the plasticity, infectivity, morbidity, and mortality of the diverse forms of the COVID-19 virus.
